1. **CALL TO ORDER**

Ms. Rossi called the meeting to order at 7:32 a.m. at City Hall, 116 Union Street, Snohomish, WA, 98290.

2. **APPROVE THE AGENDA** - Approved (6 - 0)

3. **INTRODUCTIONS** - None

4. **APPROVE MINUTES** - Minutes of the January 23, 2018 meeting were approved (6 - 0)

5. **MEMBER UPDATES**

Mr. Stocker went to a farm-agricultural tourism conference in Los Angeles. County Councilmember Sam Low was also in attendance. While there, Mr. Stocker met a consultant out of Colorado who works with communities/retailers on improving marketing and making their community a destination. Councilmember Low is working on bringing the consultant's workshop to the County, and inviting neighboring economic development professionals and business owners. Mr. Stocker encouraged the City and Committee to participate in the workshop.

6. **DISCUSSION ITEMS**

a. Pilchuck District Development Regulations Amendments

Brooke Eidem, the City's Associate Planner, shared proposed amendments to the Pilchuck District Development Regulations. On March 7, the Planning Commission will be holding a public hearing on this matter. The amendments will tweak regulations making them more flexible, allowing more uses, and encouraging further development in the Pilchuck District.

b. Subcommittee Updates

Mr. Cook said the Growth & Development Subcommittee met on the February 13 and they discussed the need for an economic analysis of the southern UGA, and for the City to work with the County. Possible future revenue from annexation of the southern UGA should be researched. Disposition of the County yard on Bickford Avenue and expansion of the northern UGA was also discussed.

Mr. Papadatos advised the Business Retention & Expansion subcommittee has not yet met.

The Tourism Committee met the previous week. They reviewed and discussed work completed by the business interns. Joseph studied downtown parking assets and Patrick focused on website and mobile app traffic. The committee updated the schedule of milestones and will continue to gather information.

7. **REPORTS**

- a. Ms. Burton provided the most current sales tax report to the Committee. The report shows 3.8% increase from the prior year.
- b. Mr. Cook updated the Committee on available properties
- c. The Commercial Permit Activity report was provided
- d. Business Lists – Lists of new and closed business licenses within last year were provided
