**ORDINANCE 2226**

**AN ORDINANCE OF THE CITY OF SNOHOMISH, WASHINGTON  
AMENDING PORTIONS OF THE SNOHOMISH MUNICIPAL CODE  
(SMC) CHAPTER 11.10 ENTITLED “PERMIT PARKING,” SECTION  
11.10.030 “PERMIT ISSUANCE AUTHORITY” RELATING TO  
PARKING PASS FEES; PROVIDING FOR SEVERABILITY AND AN  
EFFECTIVE DATE**

**WHEREAS**, the City Council deems it necessary to protect the public health and safety and promote the general welfare of the community; and

**WHEREAS**, the City finds it necessary and appropriate to update and establish regulations for parking;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SNOHOMISH,  
WASHINGTON, DO ORDAIN AS FOLLOWS:**

Section 1. SMC section 11.10.030 entitled “Permit Issuance Authority” is amended to read as follows:

**11.10.030 Permit Issuance Authority.** The Snohomish Chief of Police shall be authorized to issue, ~~permits~~ for residential on-street parking and visitor passes, and to administer the application for and use of said permits and passes. The annual fee for a residential on-street parking pass will be \$20 per pass. The Chief of Police shall issue to each person applying for a permit an information sheet containing the terms, conditions, and rules under which the permit shall be issued. Because the permits to be issued under this ordinance are intended to benefit the public street adjacent to each residence, said permits shall be issued based upon a resident showing sufficient need and taking into consideration the number of available parking spaces.

Section 2. Severability. If any section, subsection, paragraph, sentence, clause, or phrase of this ordinance or its application to any person or circumstance be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be preempted by state or federal law or regulation, such a decision or preemption shall not affect the validity or constitutionality of the remaining portions of this ordinance or its application to any other persons or circumstances.

Section 3. Effective Date. This ordinance shall be effective January 1, 2012.
