ORDINANCE NO. 1892

**AN ORDINANCE OF THE CITY OF SNOHOMISH, WASHINGTON
AMENDING SNOHOMISH MUNICIPAL CODE 2.16 RELATING TO
THE PLANNING COMMISSION, REDEFINING THE DUTIES
THEREOF.**

WHEREAS, the Snohomish City Council has determined that is necessary to periodically review the function of its Advisory Boards; and

WHEREAS, the Planning Commission is scheduled for review in March 1999;
and

WHEREAS, the Snohomish City Council finds it is necessary to reestablish purpose, qualifications, terms, and duties of the Planning Commission;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SNOHOMISH,
WASHINGTON DO ORDAIN AS FOLLOWS;

Section 1. Chapter 2.16 of the Snohomish Municipal Code is hereby amended to read as follows:

Chapter 2.16

Planning Commission

2.16.010 Created--Number. A City Planning Commission is created to serve in an advisory capacity to the Snohomish City Council pursuant to RCW 35A.63.020 and shall consist of nine members.

2.16.020 Members--Qualifications. The members of the Planning Commission shall be appointed by the Mayor, subject to confirmation by the City Council, consistent with the requirements of SMC 2.06.030 and 2.06.035. The Mayor shall strive to maintain a diverse representation of membership.

2.16.030 Appointment to the Commission—Terms—Vacancies--Compensation. Terms of appointment for the appointive members shall be in such manner as to provide that the fewest possible terms expire in any one year. The term of office for all Planning Commissioners is six years. If a Planning Commissioner resigns prior to the normal end of his term, an appointment will be made for completion of the unexpired term.

Members shall serve without compensation.

2.16.040 Powers. The powers of the Planning Commission shall be as provided by City Ordinance and RCW Chapter 35A.63, as amended.

2.16.050 Purpose, and Objectives. The Planning Commission is created for the purpose of considering land-use, regional and comprehensive plan issues, and making recommendations to the City Council. The Planning Commission may recommend moratoria and/or interim land-use controls and hold public hearings as deemed necessary by the City Council. The City's vision statement establishes the framework for Planning Commission review.

2.16.060 Officers, Rules, Election of Officers, Records, and Expenses. The Commission shall adopt rules and regulations for the conduct of its business, subject to the approval of the City Council. A majority of the membership shall constitute a quorum for the purpose of transacting business. Action by the Commission shall be by majority vote. A tie vote on a motion to approve shall constitute a failure of the motion.

Each December the Planning Commission shall elect a chairman and such other officers, as it may deem necessary for the ensuing calendar year. Such officers shall occupy their respective offices for a period of one year.

The City Planner, or his duly authorized representative, shall serve as executive secretary of the Commission, and shall be responsible for all records. All meetings of the Board shall be subject to the open public meetings act. The Commission shall keep minutes of its proceedings and such minutes shall be kept on file in the office of the City Clerk.

The Planning Commission shall write an annual report to the City Council on its activities for the previous year and make special reports as necessary in response to specific Council requests.

The City shall provide the Commission with necessary administrative support and expense budget as needed to perform the function described by this chapter.

2.16.070 Removal. Planning Commissioners may be removed after public hearing by the Mayor with the approval of the City Council for inefficiency, neglect of duty, or malfeasance in office.
